I am directed to forward herewith the application of the Sree Vidya Nikethan School, Chittoor District, to the Secretary, Central Board of Secondary Education, Siksha Kendra, 2 Community Centre, Vikas Marg, New Delhi and to state that this State Government have no Objection to accord affiliation to it subject to the fulfilment of the following conditions:-

- 1) The State Government reserves the right to withdraw the above certificate at any time if the Management fails to comply with the instructions of the State Government such as illegal removal of teachers, Non-payment of salaries to the teaching and non-teaching staff as per the approved scales etc.
- 2) Admissions should be made with the bonafide date of birth certificate.
- 3) All the un-trained teachers should be replaced by the trained teachers.
- 4) The Management should collect the tuition fee and special fee as prescribed by Government from time to time.
- 5) The strength in classes should be as per rules in force.
- 6) The Management should follow the State Syllabus for classes from I to V.
- 7) The School should follow the Three Language Formula.
- 8) The District Educational Officer or his nominee should be invited when the Management makes recruitment of candidates for various categories of posts.

( P.P.O. )

- 9) Staff salaries should be paid as per Government scales.
- 10) The Management shall open Classes I to III and IX & X during the year 1994-95.
- 11) The benefits of Teachers Provident Fund & Retirement shall be provided to the staff in the School.
- 12) The rates of fees may be revised from next year according to Central Board of Secondary Education rules.
- 13) Play facilities should be provided.
- 14) The Management should not collect donation either from students or parents for admission.
- 15) The School shall be kept open for inspection by the departmental personnel as and when required.
- 16) No pupil studying in the school now is put hardship for continuing in the same school.
